NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES AS FOLLOWS:

1. INTENT:

National Highways Authority of India (NHAI) intends to associate the RISE Krish na Sai Group of Institutions, Ongole District Prakasam, who shall voluntarily contribute its share of experience for betterment of the highway infrastructure.

2. SCOPE OF THE MoU:

The primary scope of MOU inter alia includes the following:

- (i) NHAI shall facilitate the faculty, researchers and students of the RISE Krishna Sai Group of Institutions, Ongole District Prakasam, to familiarize with the latest trends in the highway/transportation sector with a common objective of sharing the knowledge in their respective domain. All other arrangements including stay shall be responsibility of the Institute. However, depending upon availability, NHAI may extend transportation facility to the interns within the project jurisdiction.

- 7. NHAI may support creation of Lab infrastructure in the Institute and can sponsor relevant research project that helps in using alternative resource material and improving quality of roads;

Once an inprinciple consent is received from your end, the detailed modalities of such an arrangement could be worked out with mutual convenience. In this regard, I have asked my senior officer to be in touch with you with this letter and brief about the potential stretches for this purpose and mutual benefits of the collaboration.
- 4. I look forward to your support and cooperation in this endeavour of Nation building through improvement of road infrastructure of the country.

Sub: Proposal of adoption of NHs by Engineering Colleges-Regarding signing/execution and implementation of MoU.

Sir,

Ref this office letter dated 18.05.2020 and 06.07.2020 wherein ROs were requested to interact with Directors/ Principals of reputed Institutes regarding adoption of nearby NHs and signing of MoUs.

- 2. The following implementation strategy has been approved by the competent authority:
- (i) ROs should approach remaining Institutes and expedite signing of MOUs with Institutes on mutually agreed stretches. The approved MoU (circulated vide email dated 21.07.2020) could be used for signing by all ROs and in case of any deviation; the same shall be referred to HQ for approval.
- (ii) The duration of internship shall be of 2 months in a year @ INR 8,000 and INR 15,000 per month for maximum 20 UG and 20 PG students respectively. Based on experience and field requirement, the same may be reviewed in subsequent years.
- (iii) The ROs are hereby delegated powers to release internship fee as per terms and conditions of the MoU.
- (iv) As part of stake holder's consultation in preparation of DPR/Feasibility, the feedback of the associate Institute may be mandatorily obtained. However, such feedback will be of suggestive nature and NHAI will not be bound to accept these recommendations.
- (v) NHAI may support creation of Lab infrastructure in the Institute and can sponsor relevant research project that helps in using alternative resource material and improving quality of roads on case to case basis
- (vi) The interns may use the Lab Infrastructure of the Contractor or of their Institute as per availability on as required basis without any extra payment.
- (vii) Intellectual property, if any, developed during the entire process will be shared equally by NHAI and the Institute.
- (viii) ROs should upload progress on Data lake.
- 3. It is requested to ensure that implementation should start at the earliest on the stretches where MOUs have already been entered and also forward the progress on weekly basis.
